- An LLC, PLLC, GP, or LP may contribute \$8,000 (\$4,000 primary and \$4,000 general).
- PAC's may give \$23,600 to a candidate (\$11,800 primary and \$11,800 general).
- Corporations may give an annual aggregate of not more than \$1,000 unless they are registered with the state as a PAC.
- Contributions are not tax deductible for federal income tax purposes.
- Where both spouses' names are imprinted on the check, we can attribute between spouses without an additional signature. If both names are not imprinted on the check, both signatures are required.
